Hello everyone,

Hope this finds you well and enjoying some of the sunshine and warmer days we've had lately. Since our last bulletin in December, CPBH activities have been going full tilt, so we have a lot of news to share.

**Radon Gas and Building Code Enforcement are National Issues**: The case for attention and action on these two issues is clear for the well-being of citizens across Canada. We've been working hard to bring both issues to the fore. Remember that the next best window for getting your home tested is November.

CPBH wrote to every minister responsible for consumer protection across the country in 2019 about **undisclosed used furnaces in newly built homes**, but we've seen no meaningful action to protect consumers take place. As a recent step, CPBH obtained a legal opinion on whether Ontario's Consumer Protection Act (CPA) would allow this practice. The short answer is no. The opinion states that, "the CPA requires builders to disclose material facts about the furnaces that consumers are buying. The failure to do so would constitute "false, misleading or deceptive" representations and omissions. This, in turn, constitutes "unfair practice", which is prohibited by the CPA." Ask your provincial representative if it's legal to sell undisclosed used furnaces with new homes in your province.

The legacy of an example to all of Canada: Early this year, we learned that Tom Rakocevic, Humber River-Black Creek MPP, became the NDP critic for Transit, leaving behind the work he did on our files as critic for the Ontario Ministry of Government and Consumer Services. Tom brought new vigour to championing the need for a fair regime for home construction and warranty in Ontario, for consumer protection and enforcing the building code. He threw

himself into the task and brought about draft legislation that follows and goes beyond the path Justice Cunningham set out in his Tarion Review. We will not forget his impassioned speeches in the legislature or any of his work on this issue. While the Ford Conservatives nevertheless rammed through their woefully inadequate Bill 159, the oxymoron-dubbed Restoring Consumer Confidence Act that claims to overhaul Tarion, Tom's draft piece of legislation remains,

ready for another day and an example to all other provinces. Thank you, Tom.
