We have provided the attached listing of <u>litigated building code claims</u> from the <u>last 10 years</u> where <u>negligent inspections</u> have been alleged.



What we cannot tell you is whether any of these related to 'newly built homes e.g. for insufficient/faulty/inadequate municipal inspections' as we do not track that specific information. One would need to review the pleadings of each of these litigated claims to determine this, and that information would be publicly available via the court using the attached court file numbers on the list.

The City of Ottawa is waiving any further fee that can be charged to process this request since the cost is less than five dollars.
