### Hello everyone,

While CPBH has worked tirelessly for almost two decades to raise the profile of the problems with the regime for new home construction and warranty, nationally, provincially and municipally, we are of two minds about the current housing crisis in Canada.

We are deeply saddened that the situation had to reach crisis proportions to command the attention it needs. The pandemic, with its global and national effects on supply chains, economies, labour and more has no doubt precipitated the housing crisis in Canada to new heights, but the cracks in the system have been there for a very long time. Painful as this transition is, a transition is comprised of change, something we have been advocating for from day one. For that we are hopeful. Luckily, change is a subject about which we happen to know a few things.

Through the public discourse, a large audience gains an opportunity to learn many things about new home construction in Canada. This is helpful.

We keep seeing, in that discussion, the staggering numbers of homes of all kinds that need to be built at breakneck speed together with measures to help that happen. But an important element keeps getting left out of the story. The worst possible outcomes may be realized if the **quantity** of homes is the only focus. No one is talking about the **quality** of homes that need to be built.

What is the definition of quality in new home construction? We've asked, but we've found no government official in Canada who can define it, including Canada Mortgage and Housing (CMHC). What we do have is building codes.

These codes are the minimum standard for a dwelling to meet so that the health and safety of occupants is preserved. That means occupants will not hurt themselves or become sick from living in the home. It's that basic: running water, heat, ventilation, insulation, safe stairs with handrails, a roof and foundation that don't leak, and so on. What we know for sure is that the current system of building code enforcement – relying on municipalities to inspect during construction and enforce the code – doesn't work. If that problem in the system is not dealt with, building faster will be a disaster for many, many people.

We've seen lots of finger-pointing going on. There are challenges are every level of the fractured construction regime.

It has been CPBH's stated position for some time now that the federal government is the only one with the depth and breadth of ability and national perspective to address the housing crisis. They have taken on that mantel, and this is a positive step.

The new federal Minister of Housing, Sean Fraser, had this to say on September 11, 2023: "If we rely on stick-built homes by contractors across this country, we won't be able to solve this problem." The Minister has a small army of professionals and financial resources within and beyond government, he's got a huge mandate to deliver. He also said on that day, "Expect more from me that is going to help change the financial equation for builders...to continue to build affordable housing stock for low-income families...to demand that provinces and municipalities change the way that they build...in addition to the industrial strategy (training and immigration of building skilled workers)...". All positive. But we need to hear about quality. We have written to the Minister and given him our perspective.

We need a new national housing model for Canadians. The model must respond to the needs of consumers, not just industry. Let's not let a sea of non-code compliant homes flood the country, with the resulting nightmares that will produce for consumers for years to come. Let's get to work and get it right by building to code. Canadians deserve that from their governments.
