4. Pyrrhotite: Have you heard of the crumbling foundations catastrophe in Quebec?

Have you heard of this catastrophe? Most people say no. The story of homes with crumbling foundations built between 1996 and 2008 in Quebec has been billed as a major home construction disaster in Canada (<u>https://canadiansforproperlybuilthomes.com/wp-content/uploads/2024/12/Dec.-19-2019-The-Toronto-Star-Owners-of-pyrrhotite-damaged-Quebec-demand-money-from-SNC-Lavalin-settlement.pdf</u>).

Canadians for Properly Built Homes (CPBH) representatives met with those of the Coalition d'aide aux victims de la pyrrhotite (CAVP). Despite the long and devastating crisis faced by homeowners primarily in Trois Rivières, and evidence that pyrrhotite in concrete has caused crumbling foundations in a number of other locations both in Canada and abroad, there is not much knowledge among the public of the problem, the locations where it has devastated the lives of homeowners and what it takes to fix the problem. And the required fix is massive.

We will bring you more information and are grateful to the team at CAVP for their experience and expertise. 5.Great News: CPBH President, Dr. Karen Somerville, receives King Charles III Coronation Medal



We are delighted to share with you that, further to a submission nominating CPBH's President for her work, Karen Somerville received the medal at a ceremony at Parliament Hill on December 12, 2024. The medal was presented by Anita Vandenbeld, Member of Parliament for Ottawa West - Nepean.

Awarded in the UK, Australia, New Zealand and Canada, the Canadian medals have been presented to select

members of the Canadian Armed Forces, the Public Service and individuals who made significant contributions to the country or achieved accomplishments that brought credit to Canada. This is the first time Canada has issued a commemorative medal to mark a coronation. "I am so honoured to receive this recognition for the work CPBH has done, particularly during our 20<sup>th</sup> Anniversary year," Karen said. "We are grateful to have been able to help thousands during this time, exclusively with the financial support of consumers. I am accepting this medal on behalf of all the CPBH volunteers who give their time and expertise generously to make our <u>accomplishments</u> possible every day."
